***Please note – adoption fees are non-refundable.

I/We hereby agree to care for this dog humanely, including providing adequate food, water, shelter, love, and attention. Said dog shall be maintained in an adequate enclosed area or on leash at all times. The dog shall not be left outside during inclement weather. I/We agree to provide essential veterinary care to the dog including necessary inoculations and spay/neutering.

I/We agree not to sell, trade, give away, or dispose of this dog. If, at any time, I/We are unable or unwilling to care for this dog, I/We agree to contact **Boise Bully Breed Rescue**. I/We further agree that said dog shall not be used for medical or any other experimental purposes or sold or given to a pet store, supplier, or wholesaler. **Boise Bully Breed Rescue** shall have first right of refusal in assuming the care for this dog prior to any other person or entity assuming possession. I/We agree to complete and sign an owner surrender form identifying **Boise Bully Breed Rescue** as the new owner. Such form will be completed before **Boise Bully Breed Rescue** assumes possession of the dog. If said dog becomes lost or stolen, I/We agree to notify **Boise Bully Breed Rescue** immediately.

I/We agree to keep the dog described herein as a family member. I/We agree to notify **Boise Bully Breed Rescue** of any changes of home address and/or contact telephone number. I/We understand that **Boise Bully Breed Rescue** may examine and make inquiries about said dog at any time. If not satisfied with the condition of the dog, the conditions in which it is kept, or if no response is received from adopter, then said dog may, at the sole discretion of **Boise Bully Breed Rescue**, be removed and placed in a different home. Any veterinary services needed due to negligence or lack of care will be the adopter's responsibility and any costs incurred shall be reimbursable to **Boise Bully Breed Rescue**.

I/We agree that said dog will not be used for any illegal purposes and will NEVER be fought in any way. I/We understand that the dog will be immediately confiscated by **Boise Bully Breed Rescue** and all applicable law enforcement agencies will be notified, if necessary.

I/We certify that we do not live in an area where there is a "breed ban" that encompasses the breed of our adopted dog.

I/We understand that surgical, cosmetic operations, such as tail docking or ear cropping, are prohibited by **Boise Bully Breed Rescue**.

I/We understand that if the dog is adopted unspayed/neutered or needing additional medical procedures, that we shall follow the instructions of **Boise Bully Breed Rescue** to complete such procedure as soon as possible when requested.

I/We understand that **Boise Bully Breed Rescue** makes no guarantees or warranties regarding the health or temperament of this dog. I/We agree to be solely responsible for this animal, and to indemnify and hold harmless **Boise Bully Breed Rescue** from any and all claims of liability for the conduct of this animal on or after the date of this adoption. This release of liability and indemnification shall apply to all unknown and unanticipated damages resulting from my/our adoption, ownership or control of such animal.

I/WE HEREBY ACKNOWLEDGE THAT I/WE HAVE READ AND UNDERSTAND THE ABOVE TERMS AND CONDITIONS. I/WE UNDERSTAND THAT THIS IS A BINDING CONTRACT ENFORCEABLE BY CIVIL LAW. AS PROVIDED BY IDAHO CODE 9-1406, I/WE DECLARE UNDER PENALTY OF PERJURY THAT THE ABOVE IS TRUE AND CORRECT.
